03/05/2017 - Singapore aims to be LNG bunker-ready by 2020


Singapore is gearing up to refuel the growing number of ships powered by cleaner liquefied natural gas (LNG) instead of dirty fuel oil. It aims to be ready to bunker LNG to ships in the next 3 years. This follows the 2016 landmark ruling by the International Maritime Organisation to impose a sulphur cap of 0.5% on fuel oil starting 2020, from the current 3.5%. The number of LNG-fuelled and LNG-ready ships have grown to almost 100 vessels, with another 70 expected to come soon.

17/05/2017 – Early gains seen for Singapore in EU court ruling on FTA 17/05/2017 – Singapore's free trade deal with EU faces hurdle

Singapore can look to scoring early gains from a top European Union court ruling on a free-trade pact that the city-state has with the regional bloc. This comes even as the ruling by the EU Court of Justice is expected to lengthen the time for the European Union-Singapore Free Trade Agreement (EUSFTA) to come into force, as it needs approval from the 38 national and sub-national parliaments of the 28 member states in the regional bloc. The decision, which cannot be appealed, ends a yearslong state of suspension for the FTA's progress. Singapore's Ministry of Trade and Industry (MTI) said Singapore hopes to have a trade pact partially enforced.



18/05/2017 - Singapore expat packages 'among highest in Asia-Pac'

Companies sending their expatriates to Singapore offer some of the most generous expatriate salary and benefits packages in the Asia-Pacific. Coming to the Republic as middle managers, they get the 3rd

biggest packages, after their counterparts in Hong Kong and Japan, typically at \$316,000 including salary, benefits and tax. The annual MyExpatriate Market Pay survey by ECA International helps companies relocating staff with benchmarking their package against the market. Once tax here is factored into the mix, Singapore drops to 9th out of 16 markets in the Asia-Pacific's most expensive markets, owing to one of the lowest personal tax rates in the world.

25/05/2017 – Singapore is No. 3 model city in Asia-Pacific 25/05/2017 – Singapore is top Digital Nation in the Asia-Pacific

Singapore has ranked 3rd in the Asia-Pacific region, behind Seoul and Tokyo, in the latest ranking of model cities. It moved from the 29th spot, out of 180 cities, in 2014, to 28th in 2015, and to 22nd last year, in what is called the Cities in Motion Index, released by Barcelona-based IESE Business School. Meanwhile, according to the Digital Nation Scorecard, which is an assessment of 11 Apac countries by Sydney- and Singapore-based advisory firm AlphaBeta, Singapore has emerged as the top Digital Nation in the Asia-Pacific by virtue of its strong performance in attracting and retaining digital talent, providing digital companies access to financial capital, and building a strong digital community.

31/05/2017 - Singapore tops global ranking of digital competitiveness

Singapore has topped a new digital competitiveness ranking introduced this year by business school IMD's World Competitiveness Centre. The country also came 3rd in IMD's latest ranking of the world's most competitive economies, going up one place from last year's 4th ranking. While the IMD competitiveness ranking, which has been published yearly since 1989, already includes indicators like technology and scientific infrastructure, the new digital competitive ranking introduces several new criteria to measure a countries' ability to adopt and explore digital technologies which lead to transformation in government practices, business models and society in general.



18/05/2017 - 3D Metalforge opens additive manufacturing centre

Metal-printing company 3D Metalforge opened a \$2.5 million 3D printing facility, which is believed to be Singapore's first end-to-end additive manufacturing. This means it will provide a complete suite of inhouse metal printing solutions and services, ranging from design and engineering, to printing, post-production and finishing. It will make parts for the marine and offshore, oil and gas, manufacturing, engineering sectors, as well as other key industries. 3D Metalforge, established in 2016, is the sister company of 3D Matters, one of Singapore's earliest commercial 3D printing additive manufacturing companies.

25/05/2017 - Up for grabs: S\$2.4b of government tenders in Smart Nation drive

The government will be calling for a projected S\$2.4 billion worth of ICT (Infocomm Technology) tenders in fiscal 2017 in order to maintain the momentum in Singapore's Smart Nation and digitalization efforts. Announcing this at GovTech's annual Smart Nation and Digital Government industry briefing, GovTech chief executive Jacqueline Poh said the government would invest in technologies such as data analytics, sensors and related software and systems. She added that the investment would include a tender for data analytics and another for communications infrastructure to link up data centres with IoT (Internet of Things) sensors.

09/05/2017 - Driverless trucks to start trials on Jurong Island in September 09/05/2017 - Katoen Natie to test driverless trucks on Jurong Island

Logistics service provider Katoen Natie is planning to test self-driving trucks in Singapore from September this year, in a bid to overcome difficulties in hiring truck drives here. The Belgian firm is working with Dutch technology company VDL to retrofit the trucks here with autonomous systems. The project involves 3 phases; First, Katoen Natie will program trucks to run between 2 fixed points in one of the largest chemical plants on Jurong Island. Second, the transponder system will be replaced by a GPS system, and the test area expanded to a larger area within the plant. Finally, the company will start using the trucks on public roads in the third phase, potentially carrying containers between various chemical plants on Jurong Island or even to Tuas Port.
